MISSION

Building on the enduring heritage and values shared between the peoples of the Netherlands and the United States, the Netherland-America Foundation seeks to further strengthen the bonds between our two countries through exchange in the arts, sciences, education, business and public affairs.

Founded in 1921, the NAF is active in the following areas:

NAF-FULBRIGHT FELLOWSHIPS

Awarded to Dutch and American students pursuing graduate level studies at universities in each other's countries, funded by the Wilhelmina and Leendert Reuvers Educational Fund, the Loet and Edith Velmans Education Fund, and proceeds from the NAF Ball.

SCHOLARSHIPS

Awarded to high-achieving Dutch students for summer academic study and internships in Washington, DC, funded by proceeds from the NAF Ambassadors' Awards Dinner.

INTERNSHIP GRANTS

Awarded to high-achieving and low-income students through both the Dutch2USA and USA2Holland Internship Program. Awarded to young women in partnership with the Elske Doets Young Lady Business Academy, a Netherlands-based organization that aims to empower the next generation of female leaders. Awarded to graduates of the Master Global Health Program at Maastricht University, the Heersink Family Global Health Internship Fund helps graduates pursue an internship in the United States.

INTEREST-FREE STUDY LOANS

Awarded to Dutch students seeking to study in the United States and, on similar terms, to American students seeking to study in the Netherlands. Funding sources include the Maarten van Hengel Memorial Fund, Mark Pigott Family Education Fund, Samuel Freeman Charitable Trust and NAF Study Loan Fund.

J1 VISA SPONSORSHIP

For Dutch students participating in internships or traineeships in the United States.

BUSINESS EXCHANGE

Supporting the exchange of viewpoints, expertise and ideas amongst members of the business community at NAF meetings and lectures.

CULTURAL GRANTS

Supporting exchange between the United States and the Netherlands, for all areas of the arts. Both emerging artists as well as established organizations are eligible.

BOOK TOURS

Showcasing internationally recognized scholars and writers from the Netherlands in presentations throughout the NAF chapter network.

FRIENDS FUNDS

Facilitating fundraising in the United States for Dutch cultural and educational institutions. The NAF's Fiscal Sponsorship Program provides a similar arrangement for individual projects. Through this structure, U.S. donors' gifts are tax-deductible.

HISTORY

Contributions to the restoration of historic buildings and monuments and to historic research, keeping the long historical ties between our two countries vital and current.

DIGITAL MEDIA & COMMUNICATIONS

Providing access to information through a digital lens by distributing monthly updates on the Foundation's work through a digital newsletter, hosting webinars with experts who are at the forefront of their field, and engaging the Dutch-American community through social media platforms.

The NAF has chapters in Atlanta, Boston, Chicago, Houston, New York, Northern California, Southern California, Washington, DC, Western Michigan and the Netherlands, as well as an active alumni network, both in the Netherlands and the United States.

FROM THE CHAIR



DEAR MEMBER:

It is with great pleasure to present the 2021 Annual Review of the Netherland-America Foundation. We continue to build bridges that strengthen the bonds between our two nations through funding of scholar- and internships, cultural, and business exchange. Bringing people together and facilitating a dialogue between diverse groups is more important than ever. I thank you for supporting our organization and supporting us through donating your time and funding our efforts.

Thanks to the NAF's many volunteers, sponsors, and board members, we were able to deliver an impressive number of programming and support to students, interns and artists in the Netherlands and the United States in 2021:

- Funded 8 Fulbright scholars despite the travel restrictions that COVID-19 brought
- Provided 5 Dutch and American students with interest-free loans
- Sponsored 16 Dutch2USA internships
- Started a program for American students to intern in the Netherlands
- Funded 3 Dutch interns to work and study in Washington, DC
- Hosted the first in-person fundraising events after COVID-19: The Ambassadors' Awards Dinner in Washington, DC and the NAF Ball in New York City
- Launched NAF Live TV with two broadcasts: Culture Edition and Connecting Flight (KLM)
- Published the commemorative book "The Netherland-America Foundation: A Century of Bridging Worlds"
- Awarded 29 cultural grants in support of exhibitions and other cultural projects
- Continued to attract Friends Funds Program participants, by adding an additional 4 Funds

Although with limited attendance, we were able to have the first fundraiser in Washington DC this year and our main NAF Ball in New York, while the Netherland-America Friendship Gala was postponed to June 2022.

The chapters also stepped up with fundraisers. We saw support coming from the Houston, San Francisco and Los Angeles Chapters. With the help of the Dutch Consulate, we started an Atlanta Chapter, which was off to a good start with a fundraiser in 2021. Just like last year, I have an immense amount of gratitude for all our volunteers who worked around the clock minimizing the financial impact of COVID-19 in 2021.

During its 2020 December meeting, the Board approved a new strategic plan titled "Building Bridges to the Future." The plan provides a detailed roadmap for growing our membership and donor base and expanding our diverse constituent base. In line with this plan, we have seen significant increase in chapter engagement and member enthusiasm. Not only have we seen a five- to tenfold growth in event attendance through better programming and hybrid events, but we also have been measuring a substantial increase in our digital presence presence. Our monthly newsletter is received by almost 10,000 subscribers.

Our programming is also shifting focus. We received a grant for 10 podcasts in 2021, which have launched in March 2022 to cover news and current events relevant to our constituents. In addition, in 2021, we launched the USA2Holland program, a reciprocal internship program for high-achieving, low-income American interns. Moreover, we are leveraging relationships with partner organizations to provide joint programing, namely with the New Amsterdam History Center, the Roosevelt Institute, and Holland in the Valley.

In our efforts to address Diversity, Equity, and Inclusion we, for example, launched a set of webinars addressing the Dutch role in the slave trade, and the arrival of the first enslaved Africans in Virginia. In addition, we launched the Advisory Committee (AC) in 2021, representing a younger more diverse generation of our members and volunteers. The AC is actively involved in developing our future strategy. More importantly, AC members are invited to join existing NAF Committees, giving our younger members an active voice in the NAF.

The number of programs has increased substantially over the last couple of years, from seven active programs in 2017 to eighteen in 2021. We have addressed this growth through standardization of processes in our organization and automation of our back-office processes. Investments in processes and technology have also resulted in the NAF attaining GuideStar's platinum status, the highest rank, demonstrating that we use the funding you provide efficiently.

I would like to thank the many volunteers and committees that have invested their personal time and resources to making the NAF a success. In addition, I thank our donors for making the dreams of the students and artists we support a reality.

FROM THE EXECUTIVE DIRECTOR



DEAR MEMBER:

2021 was the 100th anniversary of the Netherland-America Foundation. With the support of its many members, contributors, chapters, staff, and volunteers throughout the United States and The Netherlands, we celebrated our centennial throughout the year through special events, publications, and programming. Despite the persistence of the pandemic, not only did we were able to not only continue our existing educational, internship, cultural, and business programming, but we actually grew our program offerings!

To commemorate this special year, we produced our book NAF100, a Century of Bridging Worlds, spear-headed by Theo Prudon and Angela Molenaar, and designed by Unjoo Noh. In addition, Board Member Merijn Boender wrote a monthly column highlighting each decade of the NAF, published digitally. With the alumni committee, we organized a virtual concert showcasing the talents of our former NAF Fulbright students. And of course, where possible, we celebrated our centennial in person, such as at the Ambassadors Awards dinner in Washington D.C., the NAF Ball in New York City, and the 100th-anniversary board meeting on December 1 in the Explorer Club—on the same date as the very first NAF board meeting in 1921.

I am particularly proud of the ways in which the NAF is reaching out to, and attracting, a new generation of members, volunteers, contributors, and participants. With the support of the new Advisory Committee, we are incorporating new ideas for programming. The foundation broadened its communications and outreach: We produced two NAF Live TV episodes, highlighting the importance of the arts and culture in Dutch-American relations, as well as a special episode on transatlantic aviation by celebrating the 75th anniversary of KLM's first flight from Amsterdam to New York. We launched a monthly newsletter, which highlights topics of interest to the Dutch-American community, chapter updates, and NAF programming. We began the work developing a podcast, Bridging Worlds, to bring stories and conversations on Dutch American heritage, relations, and the Dutch American experience. With our chapters, we developed a host of original webinars on topics such as history, migration stories, slavery, art and music, leadership, and other topics of relevance to our communities. Speaking of chapters, we were extremely pleased with the launch of the Atlanta Chapter of the NAF in November 2021.

Finally, the NAF solidified partnerships with other organizations in 2021. We worked closely with, among others, the Giving Back Foundation and Holland in the Valley in growing our internship program, the Roosevelt Institute for American Studies in organizing two webinars, the Dutch and American embassies and consulates, Holland on the Hill, as well as our many cultural grantees and our Friends Funds throughout the Netherlands in supporting them in their goals.

We're immensely grateful for our many friends and look forward to a promising 2022!

REPORT ON THE CHAPTERS

NAF ATLANTA

In November 2021, Atlanta became the 10th and newest chapter of the NAF, and this would have not been possible without the enthusiastic leadership and steadfast guidance of its inaugural Chairman, Bernard van der Lande. A respected local leader and businessman, his networking, fundraising, and leadership skills helped establish a successful NAF Chapter in record time. Already, two popular NAF events have galvanized the Dutch Atlanta community, with the promise of much more to come. Among his more memorable contributions was the recruitment of a diverse and experienced Board, and winning the support of a strong slate of corporate backers.

Incoming Chairwoman Miranda Reshaw echoed the sentiments of the rest of the new Board in thanking Bernard for his outstanding leadership and vision. Together they were able to kickstart their chapter with a successful Black History Month event. We had the privilege to hear from Nathaniel Smith, Chief Equity Officer of the Partnership for Southern Equity, who took us on a journey through the history of Urban Development in Atlanta. We also heard from Jennifer Tosch, the CEO of Black Heritage Tours, who joined us virtually from Amsterdam and talked about black history and the social construct of race in The Netherlands. Various perspectives were heard during the discussion panel joined by Laurens van Doeveren and Yvonne K. David, moderated by Trevor Williams. Miranda Reshaw provided some musical illustrations to complement the theme of Civil Rights and Social Justice.

The Netherland-America Foundation Atlanta Chapter is looking forward to bringing together, and broadening the horizons for, the Dutch-American community in the Southeast.

NAF BOSTON

NAF NETHERLANDS

In 2021, the Netherlands Chapter again needed to adjust its intended programming to the ever-changing COVID-situation. Quite early in the year, it became clear that the second installment of the Netherland-America Friendship Gala had to be postponed until after the summer. The NAF Netherlands Alumni Committee, co-chaired by Khadjia El Ayoubi and Sjaña Holloway, cooperated with the US Alumni Committee to host the annual NAF Connection event on March 21, making for an inspiring online event for NAF alumni and members to meet with and hear from the American as well as Dutch NAF Fulbright grantees and interns.

Building on the successful pivot of 2020, the Netherlands Chapter focused its energy on two further editions of NAF Live TV. On May 20, NAF Live TV – Culture Edition celebrated the highly successful exchange program of the NAF's Culture Committee. In an hour-long online broadcast, sponsored and facilitated by NEP and Zcene Moving Stories, recorded in studios in Amsterdam and Brooklyn, NY and hosted by the quartet of Twan Huys, Ira Kip, Suzy Delvalle and Roddy Schrock, viewers and a virtual panel had the opportunity to hear the wide range of artists, performers and others deeply involved in culture who have benefited from NAF sponsorship over decades.

On May 21, 1946 KLM opened its regular service between Amsterdam and New York, establishing an air bridge between the Netherlands and the United States that remains one of the most important routes for the KLM, also during these challenging COVID-times. 75 years later, in NAF Live TV—Connecting Flight was recorded at the National Aviation Museum, the Aviodrome in Lelystad to commemorate this milestone. Lauren Zahringer guided viewers through the history of this iconic connection interviewing aviation experts Henk Guitjens, Christian Soeteman, Ronald Dijkstra and Rob Somsen in and around various aircrafts who flew on the route in successive eras. Mr Pieter Elbers, CEO of KLM, underlined the strong connections between the two countries and between the KLM and the NAF in an on-screen contribution.

The NAF Netherlands Chapter cooperated with the Roosevelt Institute for American Studies and the NAF Executive Office on June 1 with eminent scholars discussing the history of Dutch slavery in New York, and again on October 15 to highlight and celebrate the lasting legacy of Eleanor Roosevelt.

The resurgence of the Delta-variant of the COVID-virus, in spite of the vaccination campaign, in early July once again threw a spanner in the Chapter's plans for the fall. The NAF Gala had to be postponed to 2022, as large gatherings were once again not feasible. Generously, a number of sponsors converted their disappointment into the donation

of their ticket and table sponsorship to the NAF, or deferred their reservation to the new date at Paleis Het Loo in Apeldoorn: June 11, 2022. The Alumni Committee fortunately did find the opportunity to welcome—in person with appropriate precautions—the new cohort of NAF Fulbright recipients at Halloween in Amsterdam, before the Omicron-variant caused another lockdown in December.

The Netherlands Chapter Board kept in touch through their regular virtual meetings and welcomed the new option created by the NAF Office for Netherlands-based donors to fully deduct their gifts to the NAF as part of a "periodic gift agreement" over five years or more from their Dutch income tax returns.

Some of the plans for the Centenary were kept in store for the first half of 2022, with a promising and exciting agenda to look forward to.



EDUCATION

REPORT FROM THE EDUCATION COMMITTEE

Each spring, the Education Committee carefully reviews and selects the Fulbright students who will receive a NAF-Fulbright fellowship and the students who will receive interest-free study loans.

In 2021, the Committee reviewed 40 applications from American candidates in the categories flood management (3), the arts (16), general academics (17), and pediatric cancer (4). We selected 5 students to receive NAF-Fulbright Fellowships to pursue further study, research or training at various universities in the Netherlands.

The Fulbright Center in Amsterdam submitted 16 applications in the following categories: hard sciences (4), social sciences (7), and humanities (5). The Committee selected 3 candidates to receive a NAF-Fulbright Fellowship for studies at Harvard University (education) and Columbia University (public law, American studies), respectively.

The Committee also chose 5 students to receive a loan through the NAF's Study Loan Program, supported by the Maarten van Hengel Memorial Fund, Mark Pigott Family Education Fund, Samuel Freeman Charitable Trust and the NAF Study Loan Fund.

I thank the members of the Education Committee, Arthur van Benthem, Vlad Hogenhuis, Alexander van der Horst, Wagaye Johannes, Claudia Teich Lepore, Merijn Boender, and incoming chair Eleanne van Vliet for their time, energy, and commitment in selecting the most promising candidates—both Dutch and American—to receive NAF Fellowships and Study Loans.

In particular, I'd like to thank and remember Cornelis 'Kees' de Kluyver, who passed away in March 2022, for his contributions to the Education Committee, to which he was a faithful member of for many years. We will greatly miss him.

On behalf of the Committee, I gratefully acknowledge the support from the NAF Ball and our generous NAF-Fellowship sponsors including Heineken USA, the Lucendi Foundation, the Maarten van Hengel Memorial Fund, the Northstar Family Foundation, and an anonymous NAF board member. Finally, I thank the Adams Family Foundation, family of Mark Pigott, family of Maarten van Hengel, Samuel Freeman Charitable Trust and the many other donors who supported our Study Loan Program and alumni events.

REPORT FROM THE ALUMNI COMMITTEE

The NAF Alumni Committees were hard at work in 2021 bringing our alumni and current grantees together both virtually and in person. Vivienne Aerts and Annemarie Hagenaars (based in the U.S.) and Khadya El Ayoubi and Sjaña Holloway (based in the Netherlands) led the committees in organizing the digital NAF Connection in March where a couple of the grantees spoke about their studies as well alumni Bart-Jan Polman who spoke about his current projects.

In June there was the NAF centennial virtual Concert with Elicia Silverstein and Shin Hwang. In October we had our first two in-person events: the NAF Alumni New York Picnic in Prospect Park and a Halloween-themed meetup for the Alumni network in The Netherlands.

I've been able to make molecules that rotate upon illumination (thus the name, "molecular motor") that can then move, mimicking the motion of muscles. The lab is incredibly international, so I've been able to work with brilliant people from all over. Outside of the lab, I've been loving exploring cities throughout the Netherlands, taking dance classes taught in Dutch, learning how to boulder, and making wonderful new friends. Moving across the world, finding my place within a world-renowned lab, and immersing myself in new cultures has challenged me in incredible ways, but has also been eye-opening and given me communities and experiences I'll cherish the rest of my life. 

Sharing Everything and Receiving Nothing

Unbridled personal data collection by private and public institutions steer individual and collective behavior in questionable societal development under the guise of progress. In order to secure individual freedoms and rights of people in the future, we must dispose of the dependence on large monopolies to acquire, utilize and broker, without consent and knowledge, our personal data. Collection of data is, for example, used by organizations for private gain, marketing of products and policies, crime control and behavioral analysis. Currently, data collection abides by the rules of the platforms of data possessors. Our inability to modify the set terms of engagement regarding data translates to an impotence to control an aspect of our digital profile that increasingly impacts society and personal freedom. Particularly relevant are the consequences of data accumulation on individual and collective behavior under the pretense of increased efficiency as a result of revolutionary information technology. A decentralized distributed data cloud (3DC) could provide entities with more agency in their data usage.

3RD PLACE: TESSA JAGER



Investing, Contracting, Buying: How WHOVAX will Enhance Vaccine Equity for the Next Pandemic

The COVID-19 pandemic has shown the arts of science as never before. While previous pandemics ended with the virus obstructing its transmissibility (SARS), natural herd immunity (Spanish Flu), lockdowns (MERS, Ebola), or the virus weeding out its hosts (plague), COVID-19 will likely become the first pandemic ending through mass vaccination campaigns. That humanity is able to protect itself from something as inherent part of the natural world as viruses is admirable in itself, but the fact that we considered vaccination from the beginning as the only way out shows how much we trust in biotechnology. However, now that we can end the acute phase of a pandemic by quickly inventing vaccines, an important question is how it should be most fairly distributed.

INTERNSHIP PROGRAMS

EXPANDING NAF INTERNSHIP PROGRAMS

In 2017, the NAF created the Dekker-Padget Dutch2USA Internship Program—initially funded by a \$100,000 grant from the Golden Fleece Foundation, founded by John Padget and the late Jacob G. Dekker.

The Dutch2USA Internship Program is now one of the NAF's flagship programs, designed to provide Dutch students from low-income backgrounds with the opportunity to pursue professional internships in the United States. The program directly furthers the career prospects of talented students who might otherwise not have the opportunity due to the lack of sufficient funding.

Students complete professional internships spanning a host of industries—from business to medicine to humanities—across the United States. In addition to providing a monthly financial stipend, the NAF assists with obtaining visas.

After the travel halts and complexities of 2020, travel was largely available to many students in the Dutch2USA program in 2021. Due to the availability of COVID-19 vaccinations in both the United States and the Netherlands, along with the lift of the travel ban for fully vaccinated travelers in November 2021, the NAF expects the Dutch2USA program to pick up its momentum from where it left off in 2020.

NEW PROGRAM INITIATIVES

The plans have been set for the **USA2Holland Internship Program** in 2021, with the guidance and support of John Padget and the Golden Fleece Foundation. In this initiative, highly motivated students who demonstrate a financial need will be awarded scholarships to intern at a company in the Netherlands.

With new initiatives comes a new committee! The NAF is excited to launch the Internship Committee, composed of Mary Andringa, Andrew Enschede, Jim Dykstra, and with Roel Huinink serving as chair. The strength and expertise of this group will allow the NAF to better run our internship programs and find new companies to partner with.

Additionally, the NAF partnered with Holland in the Valley in late 2021. As part of their Internships in the Valley program, bright Dutch students can gain professional experience at a wide range of Bay Area companies, from startups and scaleups to big corporations. The NAF signed on as the official J1 visa partner of Internships in the Valley, with the opportunity to increase the application pool in our Dutch2USA program and further develop connections with Dutch students and companies.

REPORT FROM THE CULTURAL COMMITTEE

In 2021, the Cultural Committee resumed funding for projects spanning cultural, historical, and artistic significance, in the NAF's century-long effort to connect the culture of our two nations.

The NAF funded 29 projects in 2021, and multiple projects that were postponed due to the pandemic finally took place made possible by relaxed restrictions. Across both countries, in various cities and regions, both established institutions and up-and-coming artists pursued a mix of projects that capitalized on the NAF's 100th Anniversary theme of building bridges.

The cultural committee carefully reviewed and evaluated the many strong applications that were submitted to the NAF after a year of reduced cultural opportunities and had to make difficult decisions. Through highlighting storied artists, like the Van Gogh Museum's Van Gogh and the Olive Groves exhibit, to an album recording featuring 100 women across the world led by NAF-Fulbright alum Vivienne Aerts, to supporting young musicians in a concert tour of the United States and the Netherlands, we look forward once again to another year of cultural exchange.

ARTISTS-IN-RESIDENCE

Jaclyn Mednicov's Residency at the SEA Foundation Tilburg, The Netherlands

As an artist in residence at the SEA Foundation, Jaclyn Mednicov continued her investigation of nature and transformation, expressed within the framework of her practice and new explorations in Tilburg. In her research, she discovered the Tulip Breaking Virus, a broken pigmentation that creates patterns on the tulip's petals. Considering how the Tulip Breaking Virus creates beauty, she thought about the global challenges we face with a virus that has led to sickness and suffering and dove into these themes on the uncontrollable power of nature.

Merel Noorlander's Residency at ITP New York, NY

Merel Noorlander enrolled in a summer residency at ITP, located in the Tisch School of the Arts at New York University, to further build upon her research and current MFA. Merel's work navigates the space between performance, technology, and social design, where she create non-normative stories and a new format of expression within a wide variety of perspectives and bodies—male, female and beyond.

CONFERENCE/LECTURE

Diversity, Strife, and Toleration in 17th-Century Breukelen from the New Amsterdam History Center

17th-century Breukelen was notable for squabbling neighbors, and as a test site for tolerance. This webinar explored the history of early settlement near today's Coney Island in Brooklyn, where tensions arose between the Dutch and the "dangerous" Lady Deborah Moody's English community at Gravesend. Speakers included Professor Alan Mikhail of Yale University and Professor Eric Platt of St. Francis College in Brooklyn, moderated by Dr. Julie Golia Curator of the New York Public Library.

Mission Margraten Plus

New York, NY & Margraten, The Netherlands

Mission Margraten Plus intends to take 15 World War II veterans to the Netherlands to visit the Netherlands American Military Cemetery in Margraten, Netherlands. These WWII heroes will visit the graves of their fallen comrades and participate in several Dutch National ceremonies recognizing their service and sacrifice in gaining their liberation over 75 years ago. This trip also plans to be a bridge of learning between Dutch and American students to share and learn from each other, discuss their understanding of World War II, and hear stories from the veterans themselves.

Zeeland Girl: Beyond Tradition at the Holland Tulip Time Festival Holland, MI

It is difficult to imagine how the beauty of tulips and traditional Dutch dress might be tied to compelling social topics like respect for each other and care for the world. Still, this is exactly what Dutch photographer Rem van den Bosch is doing in the exhibition Zeeland Girl: Beyond Tradition during Tulip Time 2022 at The Armory in Holland, Michigan. This exhibition respectfully reinterprets Zeeland's regional costume to address present-day issues in vibrant photographs that transcend traditional and progressive views. The Zeeuws Meisje #equality and #tulips series refer to the colors of the rainbow to celebrate diversity and highlight the need for inclusivity and mutual respect. Zeeuws Meisie #brotherhood focuses on social and ecological care. The exhibition shows a selection from each of the three series, including several large format photographic prints and 25 original intricate handmade dresses.

EXHIBITIONS

Bas van Beek at The Wolfsonian at FIU Miami Beach, FL

Strengthening its relationship with the Netherlands, The Wolfsonian presented an exhibition of works by Dutch artist-designer Bas van Beek, exploring design history and its interrelations with present-day production. Van Beek is interested in the richness and variety of archival material, utilizing it as a source of inspiration to playfully reinterpret acknowledged and anonymous design to create new forms and functions for mass production. Delving into The Wolfsonian's collection, the artist has identified several objects and, with his students from Florida International University and the Royal Academy in The Hague, investigated their morphology. This conceptual and practical process has resulted in the creation of new 3d printed objects based on historic designs. Along with a reflection on the preservation of design heritage, the exhibition will offer a peek into van Beek's previous work in collaboration with Dutch institutions such as Het Nieuwe Instituut, Boijmans van Beuningen, Van Abbemuseum, Stedelijk Museum Amsterdam, and Kunstmuseum Den Haag.

Designing Peace at the Cooper Hewitt New York, NY

Cooper Hewitt, Smithsonian Design Museum presents "Designing Peace," an exhibition exploring the unique role design can play in pursuing peace. The exhibition features design projects from around the world that look at ways to create and sustain more durable peaceful interactions—from creative confrontations that challenge existing structures to designs that demand embracing justice and truth in a search for reconciliation. Organized by Cynthia E. Smith, curator of socially responsible design, with Caroline O'Connell, curatorial assistant, "Designing Peace" continues Cooper Hewitt's humanitarian design exhibition series exploring how design can address some of the world's most critical issues.

Dutch Masters from The Frick Collection at the Mauritshuis

The Hague, Netherlands

In 2022, the Mauritshuis will celebrate its 200-year anniversary by organizing special exhibitions and unique projects. The anniversary year concludes with a very special exhibition: ten paintings from The Frick Collection in New York. This will be a one-time opportunity to view this selection of paintings in Europe, which (with one exception) left the continent more than a hundred years ago and have been in the United States ever since. One of the greatest masterpieces on view will be Rembrandt's self-portrait from 1658. The painter immortalized himself many times, but many consider this self-portrait to be one of the very best. The founder of The Frick Collection was the industrialist Henry Clay Frick, who also built the house where the present-day museum is located.

Insiders Grave at De Ateliers Offspring 2021 Amsterdam, Netherlands

In her presented work 'Insiders' Grave', Brianna Leatherbury met with shareholders and stock market investors inquiring about their valuable items which they would like to be buried with. After their conversations, their chosen objects: two suitcases, a harp, a digital scale, a medical info sheet, and a set of keys are then plated in copper by the artist and presented as premature artifacts of the speculative market. Leatherbury is interested in the materials of economy and finance, made visible through their circulation within the infrastructures that surround us.

Ioook&&feel | surfacestricture at the 1708 Gallery Richmond, VA

loook&&feel | surfacestricture was the first solo exhibition in the U.S. by Dutch artist Lilian Kreutzberger. Kreutzberger's ongoing practice seeks to make the ever-advancing relationship between digital and physical domains tangible. loook&&feel | surfacestricture examines the influences digital interfaces have on architectures of the material world. Visitors encountered paintings, laser-cut wood compositions, and sculptural objects that ask: if digital space was initially designed to mimic the physical world, then how is the material world responding to the now digitally lived experience? Kreutzberger positions this inquiry by considering both systems of display used for the reception of art and the negotiation between built forms, urban design, and historical architectural theory.

Love, Loss, and Laughter Various Cities in The Netherlands

Love, Loss, and Laughter is a photo exhibition created by Cathy Greenblat to show that it is possible to live well with Alzheimer's disease and other dementias with a better understanding of the disease, love for the person and good quality care. The set of over 90 photos show examples from all over the world and has been showcased in multiple places in the USA, France, UK, Italy, India, and Australia. In 2021, with the Global Charity Support Foundation, the exhibit was brought to Amsterdam, Zeist, and municipalities in Utrecht. In addition, in each city, lectures and seminars about living with dementia, workshops and other activities were organized to work out the theme of the exhibition.

Remy Jungerman: Higher Ground at the Katonah Museum of Art Katonah. NY

The Katonah Museum of Art will present an exhibition of recent works by Suriname-born Dutch artist Remy Jungerman. The exhibition will include a selection from Jungerman's three major bodies of work: wall-hung or free-standing three-dimensional assemblages (which the artist calls "horizontals" and "verticals"), stacked "cubes," and fabric-covered "panels." Through these self-imposed formal constraints, as well as a limited vocabulary of carefully-chosen materials, Jungerman explores connections between pattern and symbol in Surinamese Maroon culture and European "modernism."

Sightings: Magali Reus at the Nasher Sculpture Center Dallas. TX

The Nasher Sculpture Center in Dallas, Texas presents an exhibition of newly-commissioned work by Dutch-born artist Magali Reus as part of the Nasher's "Sightings" series. "Sighting: Magali Reus" will consist of two sets of sculptures, each playing on the museum setting. The first set distorts the Nasher's own "EXIT" signs. The second takes a bowl of fruit, one of the most common subjects of art, and ties it back to a commonplace fruit stand. Inspired by everyday objects, Reus's sculptures offer eerily precise transmutations of common items, such as "No Parking" signs or dehumidifiers. Combining minimalism and absurdity, her work evokes the disjointed character of modern life-where tensions between the digital and physical can lead to alienation and isolation.

Van Gogh and the Olive Groves with the Van Gogh Museum and Dallas Museum of Art Dallas, TX/ Amsterdam, The Netherlands


The Van Gogh Museum and Dallas Museum of Art collaborated on an exhibition dedicated to Vincent van Gogh's important series of paintings of olive groves, a series of paintings and drawings that the artist produced during his stay in Saint-Rémy-de-Provence in 1889. It is a bold and highly experimental group, which reveals his passionate investigation of the expressive powers of color, line, and subject. These fascinating paintings from 11 public and private collections clearly held an important place for Van Gogh, making it even more surprising they have not previously been the subject of a dedicated international research study and exhibition.

FILM

Casanova Reassessed by Dynamic Maestro Amsterdam, Netherlands

This 30-minute dance film is planned to is set to a cello concerto written by Dutch composer Johan de Meij with the score "Casanova." In "Casanova Reassessed," the film focuses on the women in his life and cast with professional dancers. With this story, Casanova plays a central but more minimal role, taking liberties to consider Casanova as a friend to women, more than an exploiter of them, when in reality, he was likely both. This film views Casanova as the catalyst to three women finding and achieving their own happiness. In order to bridge more worlds with art and culture, the film will have no spoken words.

Somatic Aliasing by Kate Cooper New York, New York

Kate Cooper's "Somatic Aliasing" was commissioned by The New Museum (NY) to partake in their Triennial "Soft Water Hard Stone." Overall, the moving image work Cooper produced aims to rethink the ways in which video is produced and read. Taking a position near to neurodivergency, avoiding notions of otherness and actually acknowledging other positions as important and necessary. Says Cooper, "Little is still discussed about neurodivergency in the context of visual arts, and therefore, the inclusion of such topics and people within the art world is a pressing matter. Many museum spaces remain closed off to this so it was important that the work itself is engaged in opening up discussions that actually include new audiences that are perhaps under-represented within art communities and find new and productive ways to discuss these ideas.'

INTERDISCIPLINARY

Black Revelry and If I Can't Dance, I Don't Want To Be Part Of Your Revolution

Amsterdam, The Netherlands

Black Revelry is an interdisciplinary and collaborative exploration of sociality and intimacy as it has been registered by the details in African-American artist Ernie Barnes' 1976 painting Sugar Shack. In late 2021, artist Derrais Carter staged a 'choreographic conversation' to work through understandings of movement and Black sociality. Together with If I Can't Dance in Amsterdam, Derrais launched the publication Black Revelry: In Honor of 'The Sugar Shack', which is a book-slash-LP album that invites readers/listeners into a performance meant to be made at home. Picking up on the thematics of Black Revelry Quiet Storm, a transnational radio show produced with If I Can't Dance during the winter of 2020-21, and in ongoing response to the isolation of the last years, the Black Revelry "book-album" is meant to transform the reading experience into a space of collective gathering.

MUSIC

La Damoiselle élue by the Filomena Women's Choir Various Cities in The Netherlands

The Filomena Women's Choir from The Hague debuted a concert program in 2021 titled La Damoiselle élue. The centerpiece of the program was the international première of the American composer Amy Beach's The Chambered Nautilus (1907) scored for women's choir, soprano and mezzo-soprano soloists, and piano. Three concerts were presented in three capital cities at venues with rich musical histories: De Waalse Kerk (Amsterdam), Pieterskerk (Utrecht), and De Nieuwe Kerk (The Hague). Since its inception, Filomena has celebrated and empowered women, not only through its membership but through its commitment to regularly programming music by women composers.

Fulcrum Point New Music Project and JacobTV's The Freedom Songs Various Cities

The Freedom Songs is a multimedia, musical composition by composer JacobTV written for voice, guitar, trumpet and percussion. Freedom Songs is a celebration of freedom and world peace 75 years after the end of World War II. The title comes from "The Four Freedoms" speech Franklin D. Roosevelt delivered to Congress on January 9, 1942, in which the president insisted that people in all nations of the world shared the same inalienable rights to four freedoms as Americans enjoy: the freedom of expression, the freedom to worship, freedom from want, and freedom from fear.

Bok Tower Gardens is part of the legacy of Edward W. Bok, the first president of the Netherland-America Foundation. His 1929 gift to the American people is a public garden and carillon tower in Florida that is now known as Bok Tower Gardens. Malgosia Fiebig, city carillonneur of Utrecht and Nijmegen, is slated to perform at Bok Tower Gardens in 2022. Malgosia performs weekly at Dom Tower, Willibrordus Tower, Nicolai Church, and St. Stevens Tower. During her time as city carillonneur in the Netherlands, she has traveled throughout Europe and the United States to give carillon performances.

Upcoming Album from Marius van den Brink New York, New York

Marius van den Brink has performed and recorded with well-known artists such as Jeff 'Tain' Watts, Joel Frahm, Fransesco Mela, Ingrid Jensen, Ara Dinkjian, Haley Reinhart, the Birdland Bigband and the Tonkunstler Orchestra. As a leader and side men Marius has performed at world class stages such as the North Sea Jazz Festival (Rotterdam), Birdland Jazz Club (NYC), GroundUp Festival (MIA), Sony Music Hall (NYC), The Cretan World Music festival (Greece), Jazz Forum and the Bimhuis (Amsterdam). His album is expected to debut in 2022.

The Philippe Lemm Trio's First Steps Tour Various Cities

The release tour for the Philippe Lemm Trio's third album, First Steps, celebrated the album along with Philippe's time living in New York for the past 10 years as a Dutchman. It was a reflection of his life as an artist during COVID and a showcase of the possibilities pursuing his love for this American artform. The tour took place in various cities across the Netherlands, Belgium, Germany, and United States.

Royal Conservatoire Meets Juilliard '22 Various Cities

The Royal Conservatoire and the Juilliard School of Music will combine forces for the second time in a major international program: Royal Early Music meets Juilliard 2022. Paul Agnew, British tenor and conductor of international renown and an accomplished teacher will lead 4 soloists, a choir of 20 and a combined orchestra of 34 young musicians. Paul Agnew has made his mark on all the main international stages as a specialist in the music of the 17th and 18th centuries. The repertoire will consist of works by composer Carl Philipp Emanuel Bach, famous son of Johan Sebastian Bach.

Typuhthâng

New York City and Virunga National Park in Congo

Vivienne Aerts' project Voices of Virunga/Women and Chocolate gathers next-generation female musicians to record the album Typuhthâng and empower the women of Virunga State Park in Congo. This project stems from Vivienne's work with countless talented female musicians as a Dutch vocalist and composer living in the US. More than 100 up and coming female musicians from over 40 countries are involved, along with sound samples recorded live in Virunga State Park. With every CD purchased, one receives a bar of Original Beans Femmes de Virunga, the chocolate that is truly an "all-women chocolate."

PHOTOGRAPHY

Darkwater by Steve Giovinco Various Cities

Informed by changing climate, historic events and culture, Steve Giovinco's Darkwater are night landscape photographs in below-sea level areas and at related infrastructure sites in central Netherlands. The goal is to visualize environmental transformation occurring in these communities, since climate-related statistics can be difficult to grasp. These photographs will be exhibited as enduring documents, and a portion of print sales will be donated back to local groups. Since a large portion of the Netherlands lies below sea level, requiring an intricate system of pumping stations, the region is significant for climate change study and documentation. Darkwater represents a continuation and expansion of Giovinco's long-term environmental night landscape series, including grant funded trips to Greenland, France and in the US.

The Receptionist by Robin De Puy Various Cities

Dutch artist and photographer Robin De Puy takes on the role of motel/hotel receptionist in The Receptionist, having grown up in a hotel herself. The Receptionist will consist of 18 cinematic self-portraits. The basis of the project is De Puy, who portrays herself as a receptionist, expanded with additional images, portraits of the receptionists of the various motels, photos of the motels themselves, landscape photos, sound and film. For the first time, De Puy places herself in cinematic images and takes a larger and more prominent role in her work than before; she is much more in the foreground and with the people portrayed. It is a step where previous projects come together and go one step further.

PUBLICATION


Calvinists and Indians in the Northeastern Woodlands by Stephen Staggs Grand Rapids, MI

Based on a variety of original Dutch sources that have been either ignored or underused in terms of Indian-Dutch relations, this book juxtaposes and analyzes textual, visual, and material evidence in an interdisciplinary way, drawing on the fields of anthropology, archaeology, art history, cartography, ethnography, history, linguistics, psychology, and theology. Thus, it provides a more nuanced understanding of the dynamic, interdependent relationships that developed between Indigenous and Dutch peoples in the Northeastern Woodlands during the early modern period. In a world marked by ethnocentrism, such an understanding might help us see our present world and its alternatives through a different lens.

Changing Forms: Metamorphosis in Myth, Art, and Nature 1650-1700 at the Frances Lehman Loeb Art Center

Poughkeepsie, NY

The exhibition focuses on the rich and complex concept of "metamorphosis" in early modern northern Europe, considering how its varied meanings of change, transformation, and re-creation resonated in the realms of myth and the natural world. The exhibition explores the intersection of art, nature, and metamorphosis through paintings, drawings, prints, and rare books drawn from The Leiden Collection, the Loeb, Vassar's Special Collections Library, as well as loans from Cornell University and Bard College. The Netherland-America Foundation supported a scholarly catalogue published in conjunction with Changing Forms.

Frans Hals in America by Dennis Weller Raleigh, NC

This book-length discussion covers the collecting of Hals' paintings by Americans from the last guarter of the nineteenth century to the present day. In pursuit of his extraordinary works, Americans eventually amassed approximately one third of the painter's extant oeuvre. While some of his masterpieces were returned to the art market and went back to Europe and elsewhere, a vast majority of these pictures have remained in North America. Today, paintings executed by Frans Hals can be found in numerous public and private collections from coast to coast across the US, and from Canada to Mexico. In addition to a discussion of individual pictures and their provenances, the study also examines the dealers, collectors, and scholars who contributed to this embarrassment of riches of paintings by Hals in America.

The NAF Friends Fund completed its 9th year of operation in 2021, adding 4 organizations to the program. COMMENTS ON THE FINANCIAL STATEMENTS

As fiscal year 2021 came to a close and we have another pandemic year under our belts, the NAF stood in a strong position to continue its mission of fostering mutual understanding and building bridges between the Netherlands and the United States.

Overall revenues, excluding Friends Fund and investment gains and losses, exceeded budget by \$39k or 2%.

Total expenses were under budget by \$440k or 27%. The primary driver was actual grants program expense at \$493k to a budget of \$895k. the \$402k shortfall was mainly caused by internships being delayed and scholar-ship students being unable to travel due to corona virus restrictions.

Total assets for the organization have increased by \$740k from the prior year. This increase is attributable to several key factors:

- 1) Strong market year as investment unrealized and realized gains net of fees totaled \$667k, approximately twice the amount of prior year.
- 2) The combination of meeting revenue targets and low program spending due to pandemic resulted in an increase in overall net assets of \$867k in 2021.
- 3) Full forgiveness on the NAF's two PPP loans was received in 2021 releasing \$91k to net assets.

The Netherland-America Foundation, Inc. is a 501 (c)(3) and 509(a)(1) not-for-profit organization. All contributions are tax-deductible for the purpose of U.S. federal and state taxes, to the extent permitted by state and federal law.

As the Foundation is also recognized by the Dutch tax authorities as algemeen nut beogende instelling (ANBI), contributions to the *Netherland-America Foundation* made by a Dutch-resident individual may be eligible for a full deduction against the individual's Dutch personal income tax, at the maximum Box 1 rate of 52%. Normally, gifts made by Dutch residents would only be tax deductible if made to a Dutch resident charitable organization. An exception is made, however, for gifts made to certain non-Dutch charitable organizations that are specifically designated as qualifying foreign organizations by the Dutch Under-Secretary of Finance. In a 2003 Ministerial Decree, the *Netherland-America Foundation* was listed as one of only 19 qualifying foreign organizations. Certain Dutch statutory rules limiting the deductibility will have to be observed.

GuideStar, the world's largest source of information on non-profit organizations, has given the NAF its Gold Star Seal of Transparency in 2019.

Charity Navigator, America's premier charity evaluator, gave the NAF a 4-star rating—their highest—for "its ability to efficiently manage and grow its finances, demonstrating to the public it is worthy of their trust."
